4. ENTRIES

4.1 Closing Date for Entries

Standard Entries Close on: Thursday, 02 May 2024 @20:00 hrs

Late Entries Close on: Friday, 03 May 2024@14:00 hrs

4.2 Entry Procedure

Any FMSCI competition license-holder wishing to take part in the rally must send the due entry fee and the completed entry form, to the rally secretariat before the closing date, as specified in the supplementary regulations. An electronic entry application (Internet) may be accepted. If this application is sent by fax or e-mail, the original must reach the Organizers within 2 days following the close of entries. Entry form must be accompanied by a copy of the valid competitor's license.

No amendments may be made to the entry form, except in the cases provided for in the General Prescriptions. However, the competitor/entrant may freely replace the motorcycle declared on the entry form with another from the same group and the same class, up to the moment of scrutineering.

No change of competitor/entrant may be made after entries have closed. Only the FMSCI can authorize the change.

Should it turn out, at the time of scrutineering, that a motorcycle does not correspond in its presentation to the group and/or class in which it was entered, this motorcycle may, upon the proposal of the scrutineers, be transferred to the appropriate group and/or class upon the decision of the Stewards.

By the very fact of signing the entry form, the competitor/entrant and all the crew members submit themselves to the sporting jurisdictions specified in the General Prescriptions, the Championship Specific regulations and these supplementary regulations.

For all vehicles participating in the rally, the Registration number of the participating vehicles will be checked with Govt. Applications on mobile like 'mparivahan' or any other application. If the details don't match with the Registration Certificate, documentation will not be passed for that particular competitor.

4.3 Number of Competitors accepted

The maximum number of entries accepted is 120. If by the close of entries, the organizers receive more entries than the maximum number specified in the Supplementary Regulations, then priority is given to the entries who are listed in the provisional standings of the current year Championship Riders.

Class1: Super Bike (Pro-Expert) (Group "A" Specials/series production/ Imported/Indian motorcycles)

Class 2: Super Bike (Expert) Group "A" – (Foreign Bike)

Class 3: Super Sport 165 Group "B"

Class 4: Super Sport 260 Group "B"

Class 5: Super Sport 400 Group "B"

Class 6: Super Sport 550 Group "B"

Class 7: Group "B" (S0 to S3 Scooters up to 210CC Sub Classes may be formed if sufficient entries are received)

Class 8: Group "B" WOMEN Class (Open, Indian motorcycle)

Class 9: Super Stock upto 450cc Group "D" (Privateer, Individual Entrant, FMSCI A & B Seeded Riders are not eligible)

Class 10 : Star of Karnataka (SOK) (Non Championship Open)

Any other Classes (does not count for National Championship)

The FMSCI reserves the right to introduce any other class/es that will run as support class/es to the INRC and will not be classified in the INRC classification.

4.7 Refunds

Entry fees will be refunded in full only:

- To competitors whose entry has not been accepted

Supplementary Regulations

- In the case of Rally not taking place

The organizers may refund 50% of the entry fees to those competitors who, for reasons of “Force Majeure”, duly accepted by the Organising Committee, were unable to start in the Rally.

5. INSURANCE

5.1 Insurance cover with FMSCI Permit

Competitors: A maximum of 250 competitors with valid FMSCI Competition License participating in various events across the Country on a given day are covered for Personal Accident Insurance for Rs. 5 lakhs with Rs. 1 Lakhs medical expense extension per person.

Officials: A maximum of 100 officials officiating in various events across the Country on a given day are covered for Personal Accident Insurance for Rs.25 lakhs with Rs.5 lakh medical expense extension per person.

These insurances are issued by United India Insurance Company Ltd. valid during the running of the event only. Organisers /Competitors are advised to take any additional insurances they may deem fit.

In case of an incident during the competitive sections of the rally, the Organiser will transport the Competitor to the Hospital in an appropriate vehicle. Thereon, all the expenses will be borne by the Competitor.

Riders are mandatorily required to have the necessary Motor Sport Insurance Cover and a HIGH-RISK PERSONAL ACCIDENT COVER of MINIMUM Rs. 10,00,000/- (Ten Lakhs rupees) with Hospitalization benefits (or as per the Current FMSCI Insurance Policy)

NO ENTRIES WILL BE ACCEPTED WITHOUT PERSONAL ACCIDENT COVER.

NOTE: NORMAL INSURANCE POLICIES DO NOT COVER MOTORSPORT.

5.2 Third Party Public Liability Insurance taken by the FMSCI

The FMSCI have taken a third-party public liability for Rs.5 crores incurred during the running of the rally for injury to third persons or damage to public property.

5.3 Exclusion of Insurance Cover

The Service and Reconnaissance vehicles, even those bearing Special Plates supplied by the organizers are never considered as official participants of the Rally. They are therefore not covered by the Insurance Policy of the Rally and will remain the sole responsibility of their owners.

5.4 Accident Reporting

If a rider taking part in a rally is involved in an accident in which a member of the public sustains physical injury, the rider concerned must report this to the next radio point as specified in the road book and signposted on the route. If he fails to observe this rule, the Stewards may impose on the crew responsible, a penalty which may go as far as disqualification. The laws of the country must also be complied with in relation to procedures at accidents.

5.5 Rally Cover Insurance for Competing Vehicles

The competing vehicles must possess **Rally Cover Insurance valid from Saturday, 04 May 2024 to Sunday, 05 May 2024**

6. ADVERTISING AND IDENTIFICATION

6.1 Advertising

Competitors are allowed to affix any kind of advertising to their motorcycles, provided that:

- It is authorized by the laws of India and the FMSCI regulations,
- It is not likely to give offence,
- It is not political or religious in nature; It does not encroach upon the spaces reserved for plates and competition numbers,

The advertising spaces situated immediately above or immediately below the competition numbers, as well as other suitable spaces on the rally plates, are reserved for the Organizers advertising.

Such advertising is mandatory and may not be refused by the competitors/entrants.

On the competition number panels the advertising must fit into an area of the same width (28 cm) and 14 cm high (or 2 x 7 cm high), situated above and/or below the numbers.

The text of this advertising must normally be clearly indicated in the supplementary regulations, or at the latest one month before the start of the rally in an official bulletin. Any other advertising proposed is only optional. Its refusal cannot incur entry fees greater than twice the amount of the entry fees fixed with optional advertising and this additional charge will be limited to a maximum of Rs10,000/-.

Competitors who accept the Organisers' optional advertising must reserve spaces for it, in the location mentioned by the organizers.

All the letters of the name of the event sponsor must be, at most, of the same height and stroke thickness as those of the name of the rally.

6.2 Identification Of Numbers

Three competition number stickers will be provided by the organizers. The competitors will have to affix these on rigid plates installed on their motorcycles prior to scrutiny. These must be made of rigid material and solidly constructed, elliptical in shape, measuring minimum 28 cms Length X 23 cms Width in size. The plate must be flat or slightly curved. The plates must be facing outwards, one facing forward and one on each side of the motorcycle positioned so as to be clearly visible with the rider seated.

These competition number stickers may have organizers advertising and this will be treated as compulsory advertising. For missing of one rally plate a cash penalty of Rs.1000/= will be levied. If two or more plates are missing, the penalty is left to the discretion of the Stewards which may go up to and including exclusion.

2 stickers having the Name & Blood group of the Rider to be placed as under,

- One on each side of the Petrol Tank.

7. TYRES

Motocross tyres are allowed.

ONLY MRF MAKE TYRES ARE PERMITTED.

If MRF Tyres are not available/manufactured for a particular size, only then, tyres are FREE, subject to approval.

8. FUEL

Fuel is FREE. The use of additives/Octane Boosters are permitted.

9. RECONNAISSANCE

Registration

Competitors should register their vehicle to be used in the recce and collect their recce card and sticker (if applicable) during documentation

The Reconnaissance will start as per the program. All Riders to be present with their respective bikes, with full Safety Gear, 30 minutes prior to the START Time of recce. Any Rider reporting late will be reported to the Steward and Stern action will be taken and Penalty will be levied accordingly.

This Reconnaissance will be a controlled recce in a Convoy following all the convoy rules, no over speeding, no overtaking and no stopping on the Stages. Recce Max speed limit on the Stages are 40 Kmph. Participation in Reconnaissance is compulsory. (Ref to Art.20.4.1 of GP)

- Authorization Letter (if owner is different from Rider)
- Valid Vehicle Insurance Certificate (Chassis number and Engine number should match with registration papers/RC Card/VAHAN App.
- Rally Cover insurance certificate in Original with a bar code to scan and confirm.
- Rider's PAN card copies Self attested.
- Indemnity Bond of carrying all papers. (In the Indemnity Bond, the FIRST Party must be the RIDER and the SECOND Party must be name of the ORGANISING CLUB, Titel of the Stamp Paper is INDEMNITY BOND. The matter of the Indemnity Bond in the Entry Form has to be typed on a Rs. 100/- Stamp Paper and has to be NOTARISED and submitted in ORIGINAL.

COMPETITORS ARE REQUIRED TO HAVE PASSED DOCUMENTATION PRIOR TO PRE-EVENT SCRUTINY.

11.2 Safety Gear

All riders must present their full safety gear **which has to include long sleeved Jersey, full leg trouser of tough material with padding, Chest Guard, Elbow Guard, Knee Braces/Guard, Gloves with knuckle protection, Goggles, Handlebar Cushion fixed on the Handlebar and First Aid Kit** at the time of pre-event scrutiny. The rider must wear Boots specifically made for off-road competition riding providing protection up to the shin. **Boots made for Touring or Leisure riding will not be allowed.** "D" loop strap helmets are compulsory. ECE, JIS, and Snell certified Helmets ONLY will be allowed. Action Cameras will not be allowed to be mounted on helmets or on the rider's body. Only ONE Action camera is allowed to be mounted anywhere on the motorcycle except on the handlebar. Action Cameras should be removed before entering Parc Ferme. No Cameras are allowed in Parc Ferme.

ALL THE ABOVE-MENTIONED SAFETY RIDING GEAR HAVE TO BE COMPULSORY WORN BY ALL COMPETITORS DURING THE COURSE OF THE RECCONNANSIANCE and ENTIRE RALLY.

12. OTHER PROCEDURES

12.1 Ceremonial Start

Saturday, 04 May 2024 from 16:30 hrs to 17:30 hrs

Venue: Rally HQ2

Ceremonial Start Holding area will remain open from 15:30 hrs to 16:00 hrs

- Any Bike Reporting outside the time will be Reported to Stewards for further sanctions.
- Spectators will be allowed to take Photographs of the Bikes
- Competitors who do not take part in the Ceremonial Start will be reported to Stewards for Further Sanctions
- The start Order and Interval will be as directed by the officials.
- Helmets and Complete Safety Riding Gear are compulsorily to be worn by all competitors as per Art. 11.2 of this SR

12.2 Finish Procedure-

As per Art 34.1 of the GP

Rally will finish at TC 9A. There after crews must follow the instructions of officials during the podium finish ceremony. From podium, selected Bikes are obliged to follow the route as directed to the Final Scrutineering. Rest of the Bikes will report to Finish Park Ferme and remain there till official final classification or instruction by Stewards of the meet.

While the Bikes are between Podium Finish to Final Scrutineering location, they will travel under Park Ferme regulations and will be observed by marshals.

16.1 PROTESTS

All Protests and Appeals must be lodged in accordance with Art.13 and 15 of the 2024 FIM International Sporting Code.

Protest fees

For Closed, Closed Invitation & Open Events: Rs.7080/-

For Challenges, Cups, Series: Rs.14,160/-

For National Championship: Rs.21,240/-

Deposit

If a protest requires the dismantling and re-assembly of a clearly defined part of the Motorcycle, any additional deposit must be specified in the supplementary regulations of the rally – or will be specified by the Stewards upon a proposal of the FMSCI Technical Delegate / Chief Scrutineer.

Expenses

The expenses incurred in the work and in the transport of the Motorcycle shall be borne by the claimant if the protest is unfounded, or by the competitor against whom the protest is lodged if it is upheld.

If the protest is unfounded, and if the expenses incurred by the protest (scrutineering, transport, etc.) are higher than the amount of the deposit, the difference shall be borne by the claimant. Conversely, if the expenses are less, the difference shall be returned.

Note: all fees are inclusive of taxes applicable in India.

16.2 APPEALS

Appeal Deposit: Rs.96,000/= + 18% GST. Total Rs.113,280/=

Competitors may appeal against decisions, in accordance with the stipulations set out in Articles 15.1 of the Code.

Competitors, Drivers or other licence-holders that are addressees of a stewards' decision or that are individually affected by such decision, whatever their nationality, shall have the right to appeal against that decision before the *ASN* of the country in which it was given. They must however, under pain of forfeiture of their right to appeal, notify the Stewards of the meeting in writing within one hour of the publication of the decision, of their intention to appeal.

The right to bring an appeal to the FMSCI along with the Appeal deposit expires 96 hours from the moment the stewards are notified of the intention to appeal on condition that the intention of appealing has been notified in writing to the stewards within one hour of the publication of the decision.

This appeal may be brought by fax or by any other electronic means of communication with confirmation of receipt. Confirmation by a letter of the same date accompanied by the necessary fee is required. The FMSCI will give its decision within a maximum of 30 days.

All parties concerned shall be given adequate notice of the hearing of any appeal. They shall be entitled to call witnesses, but their failure to attend the hearing shall not interrupt the course of the proceedings.

The confirmation of an appeal to the FMSCI must be accompanied by a deposit of Rs.96,000/- +18% GST. Total Rs.113,280/=.

This fee becomes due from the moment the appellant notifies the Stewards of the intention of appealing, and remains payable even if the appellant does not follow up the declared intention to appeal.

If the appeal is rejected or it is withdrawn after being brought, no part of the fee shall be returned.

If judged partially founded, the fee may be returned in part, and its entirety if the appeal is upheld.

If it is proved that the author of the appeal has acted in bad faith, the FMSCI may inflict upon them one of the penalties laid down in the Code.

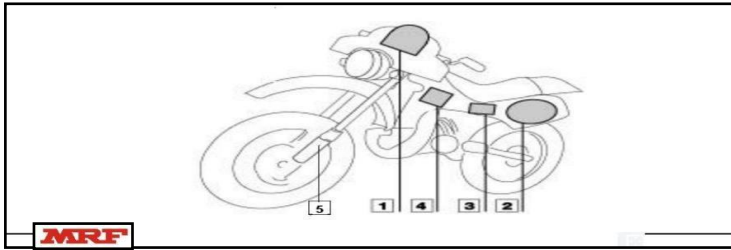

Sustainability Guidelines

Guidelines

1. General Principles

1.1 All Clubs, Organisers, Promoters, Teams affiliated to the FMSCI shall adapt their statutes in order to give proper prominence to the organisation of sustainable events and to the principles in the FMSCI Sustainability Guidelines.

1.2 Where local regulations or legislations are stricter than those contained in the FMSCI Sustainability Guidelines, then the local requirements must be followed.

1.3 Wherever an event is held, it is mandatory for the organisers to connect with an authorised/ licenced vendor of that particular municipality/ corporation for proper disposal of segregated waste.

1.4 Organisers must indicate the actions taken for the final disposal of waste.

1.5 Organisers must provide drinking water points.

2. Sustainability Officer

All events run under the FMSCI, must appoint a Sustainability Officer.

The Role of the SUSTAINABILITY OFFICER:

- Have access to all information concerning the event.
- Enforce and manage the sustainable initiatives at the event.
- Create new sustainability initiatives and improve existing ones.
- Engage the various groups involved in the event to inspire change and create legacy.
- Make a report based on the checklist drawn up by the Sustainability and Environment Commission of the FMSCI. and send it within 48 hours to the FMSCI. Failure to do this will attract suspension from these duties.
- In case of any observation on non-compliance of the FMSCI Sustainability Guidelines, the Sustainability Officer must provide details, in writing, to the COC and the Official Secretary of the event.

3. Protection of the Ground and Biodiversity

- a) Measures must be taken to prevent leaks of fuel, oil, cleaning, degreasing, cooling, and brake fluids, etc. into the ground.
- b) Containers/facilities to recover rubbish, oils, detergents, etc. must be provided.
- c) Provision must be made for the treatment of spillage and the disposal of contaminated material, by the organisers.
- d) It is strictly forbidden to empty on to the ground waste liquids from vehicles and catering facilities located in the / scrutineering/ service areas/any other. Waste liquids may only be disposed of at the circuit if the organiser has provided a proper facility to allow this.
- e) Do not leave on the spot permanent evidence of any motorsport activity.
- f) Consider using sticker rolls instead of individual stacks.

3.1 Protection of Ground

It is advised to use an Environmental mat composed of an absorbent upper part and an impermeable lower part or other effective and approved system to prevent soil and water contamination at events.

- a) wherever work on 2w /4w is allowed.
- b) In the Parc Ferme.
- c) in the Pits, under generators or anywhere that there is risk of spillage of oil, fuel, effluents.
- d) At official refuelling points.

3.2 Protection of biodiversity

When organising events in or near vulnerable areas take into account the protection and promotion of biodiversity. Consider the potential impacts on biodiversity for a temporary event such as a rally in setting the route.

4. Obligation of the participants / team members

- a) Each participant and/or team member is responsible for the waste generated by his team during the event.
- b) Where organisers provide the necessary containers for waste, they must be used as directed.
- c) Waste must be retained by the team until the approved facilities provided by organisers can be used.
- d) Used tyres must be retained by the teams or manufacturers unless storage and disposal facilities are provided by the organisers.
- e) Paper cups and single use plastic including bin liners, unless compostable, is strictly forbidden. Teams are encouraged to bring water cans/ bottles of 25 litres and reusable water bottles.
- f) These recommendations, duties and obligations must be mentioned in the Supplementary Regulations and referred to at the Briefing.

5 Sound Level

- a) All unnecessary running of engines must be avoided.
- b) Minimising excessive noise from public address systems is the responsibility of the clubs, organisers and all officials.
- c) Awareness messages on environmental behaviour can be broadcast on public address systems at approved decibel levels.

6. Sustainable Transport

It is advised to use transportation to the events that are sustainable in nature, to reduce the travel and freight carbon footprint. Following are the measures suggested to do the same:

- a) Using Public Transport
- b) Developing a culture of carpooling
- c) Optimizing event logistics; viz. remote operations, local sourcing of workforce, creating reusable and multi-year infrastructure
- d) Defining efficient routes, in terms of minimizing travel distances between events.
- e) Promoting sustainable fuels for competitions.

Appendix IV.

To All Participants

We, the organisers of the Rally of Chikmagalur, follow the FMSCI Sustainability Guidelines, the FIA Guide to Sustainable Events and the FIM Environmental Code, to the best of our abilities, for the future of our sport, and to respect nature and the environment.

We ask you to

- Use an environment mat or other approved system while servicing or refuelling in order to prevent spillage of oil and fuel into the ground.
- Use the oil collection containers available in the pits when disposing of used oil.
- Bring refillable water bottles.
- use waste bins for all rubbish.
- Please leave your pits/ service area clean, so that there is no trace of your activity.
- Not leave used tyres or parts behind. Dispose of them correctly.
- Download the FIA Smart Driving Challenge App to evaluate your CO2 emissions.
